## **Raffle Rules**

- 1. The raffle drawing ("Raffle") will be held on at February 12<sup>th</sup>, 2026, at Helena High School, 1300 Billings Ave, Helena, MT 59601 by Helena Public Schools and East Helena Public Schools ("Helena Schools"). Participants need not be present to win. Helena Schools reserves the right to conduct the drawing scheduled for that day at an earlier date after the final date of ticket sales. Tickets will not be sold after 2/10/26 at 4:00 pm. Tickets may sell out before that time. Drawings may be open to the public and are only available in-person. All ticket sales are being offered for sale in Montana State, and Raffle winner may not reside in another state.
- 2. Participants are eligible in the Raffle by purchasing a \$10.00 raffle ticket prior to the drawing. Helena Public Schools and East Helena Public Schools board members, trustees, staff, current and alumni, parents, clubs and activities will jointly offer and sell individual raffle tickets at various events. Ticket must list first and last name and phone number to be eligible. Ticket is void after the date of drawing.
- 3. A maximum of 100,000 raffle tickets are being sold by Helena Schools. The maximum chance of winning are 1 in 100,000. If fewer tickets are sold, your chances of winning the Grand Prize and other prizes improve. The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions. Consult your tax advisor. All proceeds from ticket sales will go directly to support Helena Public Schools and East Helena Public Schools. No restrictions on the number of tickets sold per person.
- 4. Participants must be at least eighteen (18) years old at time of purchase and be an individual legally residing in the U.S.A. and must be a U.S. licensed driver.
- 5. The prize available is a 2025 Toyota RAV4 LE vehicle ("Prize Vehicle") provided by the Inland Northwest Toyota Dealers Advertising Association ("TDA"). The Prize Vehicle's value is approximately \$32,986 The depiction of the Prize Vehicle in any advertising or promotional materials or physical display may not reflect the actual vehicle delivered to the winner. TDA and Helena Public Schools and East Helena Public Schools shall not have any responsibility or liability whatsoever for any property loss, damage, personal injury, or death, in connection with the Prize Vehicle provided pursuant to the Raffle and/or any person's participation in the Raffle; provided, however, that TDA shall be solely responsible for any express written limited warranties specifically set forth in the applicable Owner's Guide for the Prize Vehicle (if any).
- 10. The depiction of the Prize Vehicle (if any) in any advertising or promotional materials or physical display may not reflect the actual vehicle delivered to the Raffle winner.
- 11. The Raffle shall be staged in compliance with all applicable federal, state and local laws on February 12, 2026. The Raffle drawing will be void where prohibited or restricted by law.
- 12. Every effort will be made to contact the winner by the contact information provided on the winning raffle ticket. Helena Public Schools and East Helena Public Schools will utilize phone, email and certified mail contact as necessary. If the Raffle winner does not come forward or cannot be contacted after reasonable efforts within thirty days (30) days, the Prize Vehicle shall be returned to Helena Public Schools and East Helena Public Schools with Helena Public School and East Helena Public School taking title to the Prize Vehicle as owner and disposition in accordance with rules, regulations and directives of the Montana State Gambling Commission, which has approved the Raffle.
- 13. The winner shall be required to execute and notarize an affidavit of eligibility and liability/publicity release in the form attached hereto as Exhibit No. 1 and return such affidavit to Helena Public Schools and East Helena Public Schools within fourteen (14) calendar days.
- 14. The value of the Prize Vehicle is taxable as income and the Raffle winner will receive an IRS Form 1099 (or its equivalent) for the total value of the Prize Vehicle. The Raffle winner shall be responsible for all taxes, license, title and registration fees or other costs, including without limitation any travel or transportation costs, associated with transferring and/or winning of the Prize Vehicle (if any); provided, however, the Prize Vehicle shall be delivered at no cost to the Raffle winner at an authorized Toyota dealer

TDA, however, shall use all reasonable efforts, subject to availability, to deliver the Prize Vehicle within one hundred eighty (180) days after receipt of the aforementioned items/information. Entrance into the Raffle by purchase of a raffle ticket constitutes permission for TDA, Helena Public Schools, East Helena Public Schools and/or their designees to use the Raffle winner's name, address, photograph, testimonial or other likeness and/or prize information or personal exposition (and/or any edited portion thereof) for promotional, advertising and/or publicity purposes in any media, now or hereafter known throughout the world in perpetuity, without compensation or notice to, or further consent of, the winner to the extent permitted by law.
